KNOW YOUR RIGHTS!

What to do if immigration
agents arrive at your door

A Search Warrant MUST include:

- ✓ Date the search is to be conducted
- ✓ Time the search is to be conducted
- ✓ The address where the search is to be conducted
- ✓ Precise description of what is being sought
- ✓ Exactly where on the premises the search will be conducted
- ✓ Judge's signature

IF ICE COMES TO YOUR DOOR...

- Do not open doors to ICE agents, regardless of their reasoning.
- You have the right to remain silent.
- You have the right to counsel. Your attorney should be present before you sign any documents.
- You have the right to see their warrant. Ask them to slip the warrant underneath the door. Do not open the door to obtain the warrant.



"I do not consent to you entering."

"I plead the Fifth Amendment and choose to remain silent."



Walk, Don't Run

If you are not being detained, you may WALK away from ICE. Running can be grounds for suspicion.



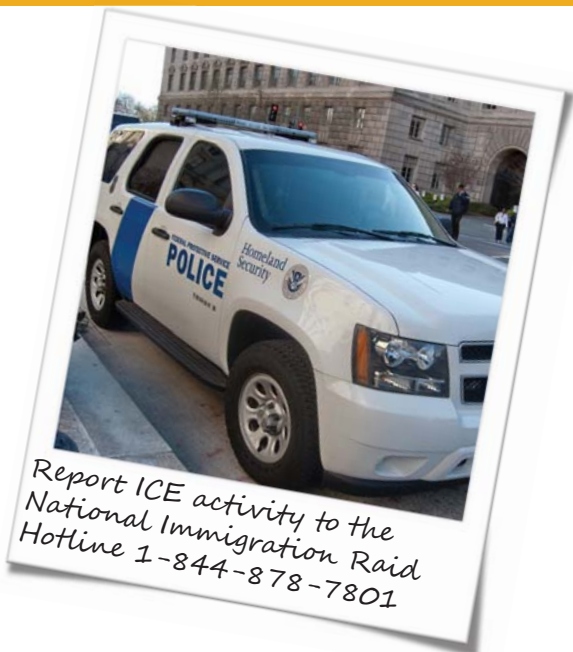
Speak to Your Kids

"Leave the door closed to strangers, even when in uniform, no matter what they say!"

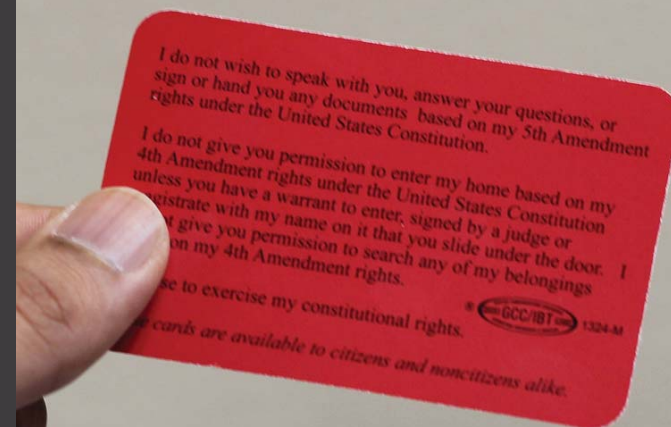
ARREST WARRANT BASICS

ICE may issue their own arrest warrant for a specific individual. The same rules for accuracy in a Search Warrant apply to an Arrest Warrant.

If any of the information is inaccurate or missing, the warrant is invalid and can legally be ignored.
